



Established in 2002, the Fund for Public Health NYC (FPHNYC) is an independent nonprofit. Founded to manage a large federal grant aimed at improving hospital emergency preparedness following 9/11, FPHNYC has grown and evolved. We are the only dedicated nonprofit partner of the NYC Department of Health and Mental Hygiene (the Health Department). While the NYC Commissioner of Health serves as the Chair of FPHNYC's Board of Directors, the Fund operates independently.

FPHNYC connects the Health Department to private sector partners, funders, and donors to develop, pilot, launch, and scale innovative public health projects quickly and flexibly. FPHNYC provides the Department with project management, budget development, fundraising support, fiscal compliance, as well as personnel hiring, onboarding, and management. FPHNYC's partnership with the Health Department has proved critical to addressing existing and emerging public health challenges.

Since its inception, FPHNYC has raised more than \$500M through grants, contracts, and other awards to address NYC's biggest public health challenges, including COVID-19, maternal mortality, food access and nutrition, tobacco control, and access to life-saving vaccines. Many projects piloted by FPHNYC have been scaled City-wide, leading to improved health and safety for all New Yorkers. FPHNYC's current portfolio supports the goals of the City of New York's [HealthyNYC](#) campaign to improve and extend the average New Yorker's lifespan.

FPHNYC has a strong track record of effective project management and grants administration. During the COVID-19 pandemic, FPHNYC was a crucial partner to the Health Department and the City of New York, managing over \$50M in emergency funding to respond quickly and effectively to the once-in-a-century public health crisis.

We work with more than 1,000 community-based organizations (CBOs) across NYC, offering capacity-building assistance and funding to implement innovative programs in partnership with the Health Department.

By securing and effectively managing public-private partnerships, FPHNYC enables the Health Department to streamline, safeguard, and scale public health programs that impact everyone who lives in, works in, or visits New York City.
